6.2.2: Implementation of e-governance:

St. Joseph's College for Women adopts a simple and automated system to equip governance to manage different elements of the academic and administrative system. The various functions to be implemented for effecting Administration, Management of finances and accounts, providing Support to the students such as payment of fees, Organizing the examinations and evaluations etc., have been considered as a set of module based packages. Each module is separately designed and implemented through an in-house developed ERP system using outside expert agencies for design and continuous maintenance and technical support. All functionaries and administrators use the ERP system for providing the e-governance services. Transparency of everything executed in the college is exhibited through the ERP system. The ERP system has been built with interface and links to the St. Joseph's web site for hosting all important contents that must be made known to the stake holders of the college.

All administrators are continuously monitoring the discipline of the students through 180 CC TV Cameras installed in the college campus.

Finance and Accounts:

Tally Software is used for financial documentation, accounts maintenance, salary payments and bill payment through NEFT system in different banks. College fee from students was collected through online mode, which is available in the college website.

Student Admission and Support:

Admission Process has been implementing though website, after the student admission into their course, the complete students details are recorded maintained and upgraded in EZ School Software. The software is accessed by Administrative Office.

Examinations:

As a part of CIA examination all students attend an online exam, per each semester at college computer labs. Examination Cell conducts these exams through software, provided by Jayamas Software Solutions. Semester End Examination and Exam results of students are displayed online on college website.
