You had submitted data for India Rankings 2019, it is informed that in order to further process your application, **you are requested to confirm that the information mentioned under the DCS heading “Student Strength :Economically and Socially Challenged Students receiving full tuition fee reimbursement”**.

To facilitate the institution to correct this data, we have created a page in DCS in which after login with your respective disciplines ID you have to either confirm or edit the “Economically and Socially Challenged Students receiving full tuition fee reimbursement” for the programs entered earlier. The page will be available in DCS from **22nd February 2019 to 28th February 2019 till 5pm**. If an institution fail to comply, the decision of NIRF committee will be final.

While entering data in DCS, please follow the following guidelines:

- 1. The parent's income of the students which are included under Economically Backward category is less than the taxable slab i.e. 2.50 lacs.**
- 2. The students which are included under Economically Backward category should not be included under Socially Challenged (SC+ST+OBC Including male & female) and vice versa.**

3. The students receiving full tuition fee reimbursement shall only be entered. Students receiving partial tuition fee reimbursements and scholarships shall not be entered.
